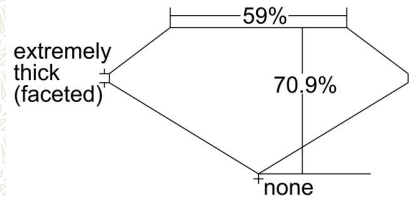


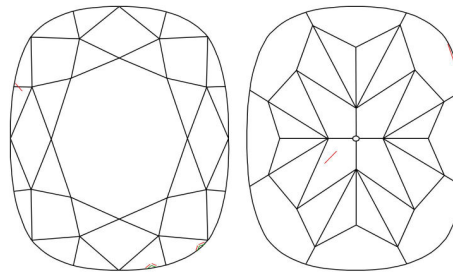

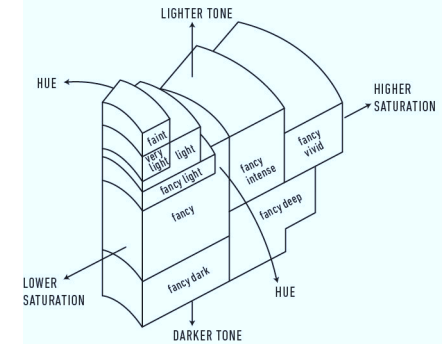
**GIA COLORED DIAMOND SCALE**
